

Processing of personal data

1. Information on the processing of personal data

In connection with the processing of your personal data by JL Navigator, s.r.o. the travel agency, as the Controller, hereby provides you as a person whose personal data we process (hereafter Data Subject) with the information according to Articles 13 and 14 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regards to the processing of personal data and on the free movement of such data (hereafter Regulation).

Controller of personal data

JL Navigátor, s.r.o. travel agency, registered seat: Nová 2859/48, 901 01 Malacký, Slovak Republic, IČO 46808060. The company is registered in the Business Register of the District Court Bratislava I., Section Sro, Insert No. 83577/B (hereafter JL Navigator).

The purpose of the processing of personal data by JL Navigátor

The purpose of processing the data subject's personal data is to offer products and services and to provide information as part of direct marketing.

The legal basis for the processing of personal data is the consent of the data subject for the purposes of offering products and services and providing information in the context of direct marketing.

Categories of recipients to whom personal data may be provided

JL Navigator does not provide personal data about the data subject for the purpose of direct marketing to another third party nor does it carry out their cross-border transfer to third countries.

Storage period of personal data

JL Navigator is authorized to process the personal data of the data subject for the time necessary to achieve the purpose of processing for at least 5 years after its release. The processing of personal data is possible only during the period for which the consent was granted.

Profiling

JL Navigátor does not profile its clients.

Rights of the data subject

- The right to request access from JL Navigator to your personal data
- The right to correct personal data
- The right to delete personal data
- The right to limit the processing of personal data
- The right to object to the processing of personal data
- The right to the portability of your personal data
- Right to withdraw consent (if consent is the legal basis of processing)

- The right to file a complaint with the supervisory authority, Office for Personal Data Protection of the Slovak Republic

The rights of the person concerned are specified in Articles 15 to 21 of the Regulation. Data subject shall exercise those rights in accordance with the Regulation and other relevant legislation. Data subject may exercise his rights by written request or by electronic means.

2. Consent to the processing of personal data

The client (data subject), by sending the form as a serious, freely given, specific, informed and unambiguous indication of the data subject's wishes, according to Act 18/2018 Col. on the protection of personal data and on the amendment of certain laws and according to Regulation, agrees with the processing of following personal data by JL Navigátor:

for the purpose of direct marketing and correspondence.

Failure to provide consent to process personal data results in the unsuccessful realization of the purpose of the service the client requests.
